Terms and conditions for Win a Belgian Beercation Giveaway 2025

- **1. PROMOTION PERIOD.** Promotion begins 7P.M. EST, February 15, 2025, and ends at approximately 9:00 p.m. EST, August 26, 2025, when a winner will be chosen at random among participants who attend the full Zoom online beer tasting and/or have entered at one of the events where Bon Beer Voyage was represented.
- **2. ELIGIBILITY.** This sweepstakes (the "Promotion") is only open to legal residents of the 50 United States and District of Columbia who are at least 21 years old as of the date of entry, except officers, directors, members, and employees of the Sponsor, the judging organization (if applicable), or any other party associated with the development or administration of this Promotion, and the immediate family (i.e., parents, children, siblings, spouse), and persons residing in the same household, as such individuals. This Promotion is void outside the 50 United States and the District of Columbia, and where prohibited.

3. HOW TO ENTER.

1. Online Entry (Zoom Tasting Attendance):

Then, attend the live Zoom tasting event on July 30, 2025, at 7:00 PM EST. Attendance at the Zoom event is mandatory for entry into the giveaway. No payment is required to attend, though any payment made for the class is voluntary. Attendees are not required to drink during the event and may simply watch the class without participating in the tasting.

2. Event Entry (Beer Festivals):

Participants may also enter by submitting an entry form at any beer festival where Bon Beer Voyage is represented. This includes, but is not limited to, events such as:

- o Florida Brewers Guild Fest
- Best of the Belgians Fest
- Other beer festivals across the country.

If a participant attends multiple events (e.g., two festivals or one festival plus the Zoom tasting), they will receive one entry for each event attended. Participants may enter once per event.

All entrant information, including email addresses, is subject to the applicable Sponsor(s)' Privacy Policy.

- **4. WINNER SELECTION AND NOTIFICATION.** Winner selection will be conducted by random drawing from all eligible entries on or about 9:00PM EST on August 26, 2025. (the "Drawing Date"). Any potential winner will be notified online at the time of the event. This will be followed up by mail, email and/or telephone.
